I want to also add the person that filed the DMCA notice is not only a joke, but as far as I am concerned I am filing a counter-notice and am not required to link the counter-notice to the copyrighted work in question. A: In your particular case, I'm guessing that you don't have any commercial interest in these texts, but your signature line is 'Please Remove Copyright Infringement Info before publishing.' That's why I'd remove that. By adding that line, you're implying a commercial interest. You're saying 'Hey guys, you are going to be allowed to publish this, but only if you remove the copyright infringing info from your site before you do so.' That is not the case. You are welcome to remove it, but the whole point of using a DMCA notice is to remove it. The response isn't 'Do what you want and leave us alone.' It's 'No, you have to follow the letter of the DMCA.' A: I agree with the general idea, but I do think it's a little weak when the DMCA notice is just a "Please remove our copyright infringement info before publishing". It should include something like, "We believe that you are in the wrong, and are removing this content as a courtesy to you". The DMCA may be better used to ask for a link to where the content came from or where it can be found. It's actually really lame that they didn't include that, since they are publishing a site that allows for the casual removal of copyrighted content, so they should include the information that allows for that. A: These people clearly made a mistake when they filed the DMCA request, but their request might be taken seriously because they did this on your site. Your DMCA server seems to be sending the request to "The Center for Copyright Information" at a-o.net, which is owned by the RIAA. This is what you do if you do not believe that you are infringing on someone else's copyright. Under US copyright law, removing infringing content is considered "termination of the copies" and is exempt from some of the protections the law gives to the copyright holder. This is one of the reasons why copyright holders are required to provide a DMCA counter-notice when sending DMCA requests. If you provide a valid counter-notice, the copyright holder will generally delete the infringing content. 2d92ce491b
