In such a situation, there can be 'no genuine issue as to any material fact,' since a complete failure of proof concerning an essential element of the nonmoving party's case necessarily renders all other facts immaterial. The moving party is 'entitled to judgment as a matter of law' because the nonmoving party has failed to make a sufficient showing on an essential element of her case with respect to which she has the burden of proof. If the respondent fails to meet this initial burden, the burden does not shift and the petitioner is not required to produce evidence supporting the existence of a genuine issue of material fact."
