

British Citizenship By Descent Grandparent: Eligibility And Requirement



A person can get UK citizenship based on their origin by applying for [British citizenship by descent grandparent](#). Based on where and when you were born, as well as the history of your parents or grandparents will determine whether you are qualified or not. Some people automatically get British citizenship by descent grandparent through this process, while others must apply to prove their citizenship.

Eligibility for British Citizenship By Descent Grandparent:

There are two types of British citizenship recognized by UK nationality law: citizenship by descent and citizenship other than by descent. A person born outside of the UK but has acquired citizenship through a UK-born parent or grandparent is referred to as a British citizen by descent. Different requirements relate to British citizenship by descent depending on when you were born and the circumstances of your parent(s) or grandparent(s) at the time of your birth.

British Citizenship by Double Descent:

If one of your grandparents was born in the UK or was a British citizen at the time of your birth, you may be eligible to petition for citizenship in specific situations. This process is called dual descent for British citizenship. Double descent claims are assessed on a case-by-case basis, and you must have enough proof to support your claim.

What is the difference between registration and automatic citizenship?

A person will automatically be eligible for British citizenship by descent if they satisfy the primary conditions for each of the following categories. They can now apply for a letter confirming their British citizenship instead of completing an official [citizenship application](#). Additionally, they will be eligible to apply for an adult or child British passport.

A person must register citizenship if they are eligible for British citizenship by descent but must fulfil the normal standards. An application form must be filled out, and supporting documentation must be submitted as part of this procedure to verify your identity.

Depending on the specific route you choose to take to [apply for British citizenship](#), you will need to fill out a specific form. Those who were born before 1983, for example, may need to complete various paperwork depending on whether they are applying through their mother or father.



You will be asked to schedule an appointment at a UK Visa and Citizenship Application Services (UKVCAS) service location as part of the application procedure. At the appointment, you will be required to pay £19.20 for providing your biometric data (your fingerprints and a photo).

How long can you expect to receive a decision?

In most cases, you should hear back from us within six months of the application's submission. If additional information is required, the Home Office will let you know. If further information is requested, the application process will take longer. Inform the Home Office immediately if your situation changes. Whether you have moved, got married, or been arrested is included.
