UK Visitor Visa Extension: Document Requirements, Cost and Application Timeline



A <u>UK Standard Visitor Visa</u> is an application for entry clearance. It is ideal for people coming to the country for business, tourism, medical care, education, or just to see friends and family.

If you have visited the UK for a shorter time than the allowed six months, you can extend your UK visitor visa extension. For instance, you can extend your Visitor Visa if it was first issued for three months.

You may be able to extend your stay in the UK if you have had a Standard Visitor Visa for at least six months, but only under specific circumstances. To extend your stay on a UK visitor visa extension beyond six months, you must fulfil the requirements listed below.

Anyone in the UK with a UK standard visitor visa must take action before the expiry of their visa. If you remain in the UK after your visa expires, you will be considered an "overstayer." **Overstayers in the UK** must leave the country immediately, and their chances of having their future entrance or visa approval denied by the Home Office are significantly higher.

Eligible Categories for UK Visitor Visa Extension:



Visit the <u>Visa category for the UK</u> that is extensible. Standard UK visitor visas fall into the following categories:

- Visit on Business
- Visit to Study
- Visit as an Academic
- Visit for Medical reasons

The validity of a UK Standard Visitor Visa is six months. Not every category is able to apply for an extension. Additional extensions of six months are allowed under the following specific conditions:

- A patient undergoing medical care.
- A scholar.
- The graduate must retake the Professional and Linguistic Assessment Board (PLAB) test.
- A recent graduate is participating in a clinical rotation.

Reasons and Requirements for UK visitor visa extension:



As a Client Receiving Medical Care:

Those with medical issues who need private consultations or treatment from a doctor in the UK are eligible for a visit visa on medical grounds. The individual must meet the prerequisites for this type of visa, which include having the money to pay for their medical care in the UK and having made the required arrangements for treatment or consultation. The validity of this visa is for six months. If the individual is receiving treatment from NHS doctors or a medical professional, you can request an additional six-month extension by submitting supporting documentation to <u>UKVI</u>.

As an Academic:

If you can prove to the UKVI the following, you may be able to extend your academic stay in the country:

- It will be essential for you to prove your exceptional qualifications in your area of expertise.
- You will need to provide proof proving you are employed at an international academic institution in your field of expertise.
- You will need to provide evidence that you are not taking up a full-time teaching position.
- You can apply to stay for a maximum of 12 months if you are currently in the UK and have authorization to visit for a shorter period than 12 months.

A graduate with clinical affiliations or retaking the Professional and Linguistic Assessment Board (PLAB) exam:

- A graduate's stay may be extended for the duration of their whole stay in the UK if they choose to repeat the PLAB Test.
- To make sure you don't overstay in the UK, you must talk to one of our <u>UK</u> <u>immigration lawyers for legal assistance</u>.

Required Documents for UK Visitor Visa Extension:

The following documents must be included with the extension application:

- A copy of the passport being applied for
- Bank statements proving you have enough money in the UK to sustain yourself
- Reasons for extension
